This release and waiver extends to all claims of any kind or nature whatsoever, foreseen, or unforeseen, known or unknown. The terms hereof shall serve as an assumption of risk, release, and waiver for me, my student, my family, and our heirs, executor, guardians, or anyone else who might assert a claim on my student's behalf.
